A Year of Growth

Dear Friends,

As we reflect on four decades of impact, we are filled with profound gratitude for your unwavering support of Hanley Foundation. For more than 40 years, your commitment has been the cornerstone of our ability to bring healing and hope to individuals and families affected by the disease of addiction.

During the past fiscal year (July 1, 2023 – June 30, 2024), our prevention programs made a significant impact, reaching over 163,000 students across 32 Florida counties. Through our evidence-based programs, we proactively worked to delay first substance use, a critical protective factor shown by research to significantly reduce the likelihood of developing a substance use disorder. Beyond our prevention efforts, we awarded nearly 350 treatment and recovery scholarships to those in need. Through our Lifesaver Scholarship Program, we continued to break down financial barriers and ensure access to the high-quality care vital for lasting recovery.

Another significant milestone in our journey during fiscal year 2024 was the acquisition of Hanley Center on December 8, 2023. Bringing the center back to its nonprofit roots has allowed us to create a center of excellence for behavioral health that is actively contributing to research and education in our field. Our patient-centric, evidence-based, holistic treatment maintained an average satisfaction score of 99.25%, laying the groundwork for meaningful and sustained recovery.

Thanks to the generosity of our lead donors, Hanley's \$35 million Campaign for Recovery is well on its way to expanding services for underserved populations, including veterans, first responders, peripartum women, and children affected by addiction. Later this year and into 2026, construction on our Resource Center will allow us to offer innovative vocational and life skills initiatives, including a planned coffee shop and bookstore staffed by our own recovery community.

Together, we will continue to break barriers, revolutionize recovery, and bring behavioral healthcare into the next era. Thank you for your unwavering commitment to turning our vision into reality.

40 Years of Impact

1984

Hanley Foundation is established by **Jack and Mary Jane Hanley** with a mission to provide substance use disorder resources in South Florida.

1998

Hanley Center opens its **Center for Older Adult Recovery**, the first dedicated addiction treatment program specialized for older adults.

2008

Hanley Resource Center opens as a prevention and training site for the public.

2015

Hanley Center introduces **Headwaters**, a premiere program for executives and individuals of affluence and high net worth.

2022

Hanley Center expands its services, adding an eight-bed **residential mental health program**. Hanley Foundation introduces its **Zero Suicide Initiative**, a grant-funded program providing suicide prevention training and support.

2024

Hanley Foundation expands its renowned **family programming** to include support for children and launches its **Patriots Initiative**, adding weekly Patriot-specific groups focused on providing addiction and mental health treatment services for veterans and first responders. **Casa Flores**, Hanley's program for perinatal women, opens five beds for pregnant women and their children. Hanley Foundation launches the public phase of its \$35M **Campaign for Recovery**, a capital initiative aimed at revolutionizing behavioral healthcare through innovative programs and state-of-the-art facilities at Hanley Center.

Jack and Mary Jane Hanley break ground on Hanley Center, a nonprofit residential facility in West Palm Beach, to address a gap in South Florida's quality addiction treatment.

2000

Hanley Foundation expands its services to provide evidence-based **youth prevention programming**.

2010

Hanley Center introduces a **5-day family program**, revolutionizing family recovery services.

2016

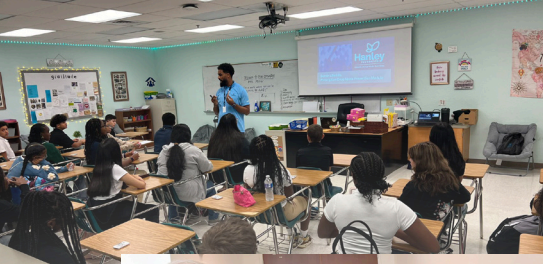
Hanley Foundation reaches a milestone in its prevention efforts, **increasing the age of first use from 9.5 to 14 years**.

The Patriots Initiative offers a blend of cognitive-behavioral, trauma-specific, and systemic therapies alongside traditional psychotherapy and pharmacological treatments. The Casa Flores perinatal program, **launched in September 2024**, addresses a critical gap in community services by providing a continuum of care for pregnant and postpartum moms and their babies. Our model allows women to simultaneously access high-quality prenatal care and substance use disorder treatment.



Key components include in-residence care featuring suites for mom and her new baby, providing medical, psychological, and clinical treatment for substance use disorder, provision of necessary supplies, and support from doulas during prenatal, birth, and postpartum phases. **The program focuses on preserving the mother-infant relationship.** The pilot program currently serves five pregnant/postpartum women at a time.

In partnership with the National Association for Children of Addiction (NACoA), Hanley's Multi-Day Children's Program, which **launched in November 2024**, is specifically designed for children ages 7-12 affected by a family history of addiction. This child-centered program aims to provide a supportive and nurturing environment for children to learn, heal, and develop resilience. Our goal is to break the generational cycle of addiction by empowering children and fostering their healing journey.
